CHAIRMAN'S MESSAGE MARK OERTHER

Why raise the bar when you can help us raise the roof.

You may wonder what the board actually does. The official explanation is to give you the mission statement as stated on the KBHI board site. "The purpose of the Kentucky Board of Home Inspectors is to administer and enforce the statutory authority and to monitor the needs of the consuming public. The board examines and certifies all eligible candidates for entry into the profession of home inspection. It recommends appropriate changes in the law to assure fairness and equality. The board conducts formal hearings when necessary and prosecutes by due process any violators of KRS 198B.700 - KRS 198B.738. What we actually do as a board is to help the industry and all parties involved. This would include not just the home inspectors but the general public.

First and foremost an inspector needs to be a professional. Professionalism is when a person conforms to the technical and ethical standards of his/her profession. Professionals are direct, polite and don't allow their emotions to overtake them. Instead of reacting to circumstances or people, the professional stops to think about their actions before responding. Take action when needed, but avoids being a reactionary person. Treat everyone with the same level of respect. Maintain a sense of responsibility and duty/standard higher than the norm. A professional home inspector is willing to maintain their knowledge while constantly building on their education, formal training and work experience with professional development through dedicated commitment of continuing education.

Our job as an inspector is to document the facts within the inspection and impartially within our standards and provide appropriate recommendations to enable the buyer to make an informed decision. Practice only within our boundaries of competence based on education, training and professional experience as well as other professional credentials. Some home inspectors carry other trade licenses.

APPLICATION COMMITTEE REPORT

NOTICE TO ALL LICENSED HOME INSPECTORS | AVOID PAYING A LATE FEE WHEN RENEWING YOUR LICENSE

In order to avoid paying a late fee you must submit the following:

- A completed Licensed Renewal Application downloaded from the state KBHI website
- Copies of completion certificates from board approved continuing education course providers.
- Certificate of Insurance which documents general liability coverage of at least Two Hundred Fifty Thousand Dollars (\$250,000), and lists the certificate holder as the Kentucky Board of Home Inspectors, 911 Leawood Drive, Frankfort, KY 40601
- Kentucky State Police Background check: Current Kentucky residents must submit a recent Kentucky State Police Background check. Out-of-state residents must submit a criminal background check from the state in which you live AND a recent Kentucky State Police Background check. All applicants must submit a background check from each state where you have resided in the past 5 years AND a recent Kentucky State Police Background check.
- Photo required passport quality, color, 2-inch x 2-inch. Do not staple or adhere to the application.
- Copy of a complete home inspection report that has been performed within the last twelve (12) months.

<u>NOTE:</u> Failure to submit "all required materials filled out properly" post marked by the last date of your birth month will result in a late fee of \$250.00.

Do not wait to apply for the state background check. The background check should be applied for in advance to ensure that it will arrive back before the end of the month. It is your responsibility.


