CALL TO ORDER AND GUEST WELCOME

Board Chair Chandler called a meeting of the Kentucky Board of Home Inspectors to order at 10:04 a.m. Members Chandler, Hiten, Ogden, and Halcomb were present. A quorum was established. Introductions were made, and guests in attendance were welcomed.

Approval of May Minutes

Member Hiten made a motion to approve the April meeting minutes. The motion was seconded by member Ogden. With all in favor, the motion carried.

KREA Executive Director Comments

KREA Executive Director Robert Astorino addressed the Board. He first reminded all Board members to check their government issued email at least once a week to avoid expiration of the account. Mr. Astorino also stated no KBHI education providers are participating in the common course initiative. The Kentucky Board of Appraisers office is currently located in Richmond, but at the end of July they will be moving into the Mayo-Underwood building. Lastly, Mr. Astorino expressed interest in trying to grow the home inspection profession.

Licensure Report

Board Administrator Tatum Herrington gave the licensure report. As of March 22, 2022, there are 608 active licensees, fifteen (15) inactive licensees, and thirty-one (31) inactive non-renewal licensees, with a total of 654 licensees.

Education Committee Report

Member Hiten recommended denial for the above InterNACHI courses.

Member Halcomb made a motion to deny "Sewer Scope Training Course" and "Become a Home Inspector Training Course". Member Ogden seconded the motion. All in favor, the motion passed.

Online KY Law & Report Writing

Board administrator Tatum Herrington addressed the Board regarding the required KY Law & Report Writing courses for licensees. Due to the COVID-19 pandemic, the Board had previously voted to allow the face-to-face KY Law & Report Writing courses to be done online. Ms. Herrington asked the Board if they were still wanting to allow these courses to be offered online.

Member Ogden made a motion to allow KY Law & Report Writing courses to be completed online through December 31, 2022. Starting January 1, 2023, KY Law and Report Writing courses must return face-to-face. Member Hiten seconded the motion. All in favor, the motion passed.

Application Committee Report

Board Administrator Tatum Herrington reported the following:

The application committee reviewed fourteen (14) applications. Of those applications thirteen (13) were approved and one (1) was deferred.

Member Hiten made a motion to accept the recommendations of the committee. Member Ogden seconded the motion. All in favor, the motion passed.
